“Oregon’s Great Outdoors” Sweepstakes

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

SPONSOR/ADMINISTRATOR: The “Oregon’s Great Outdoors” Sweepstakes (the “Sweepstakes”) is sponsored and administered by The Oregon Tourism Commission (dba Travel Oregon), 319 SW Washington Street, Suite 700 | Portland, OR 97204 (the “Sponsor”).

ELIGIBILITY: The Sweepstakes is open and offered only to legal residents of the United States and Canada (except Puerto Rico and Quebec and where prohibited by law), who are 21 years of age or older at the time of entry. Employees of Sponsor, and its affiliates and subsidiaries, and their immediate family members (spouse, parent, sibling and their respective spouses, regardless of where they live) or persons living in the same households of such individuals, whether or not related, are not eligible to enter the Sweepstakes or win a prize. **THE SWEEPSTAKES IS VOID IN PUERTO RICO, QUEBEC AND EVERYWHERE OUTSIDE OF THE UNITED STATES, CANADA, AND WHERE PROHIBITED.**

AGREEMENT TO OFFICIAL RULES: By participating, Entrants (the “Entrants”) agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. Winning the Grand Prize (prizes defined below) is contingent upon fulfilling all requirements set forth herein.

ONE WAY TO ENTER: The Sweepstakes begins at 12:00:01 a.m. Pacific Daylight Time (“PDT”) on February 14, 2020 and ends at 11:59:59 p.m. PDT on March 15, 2020 (“Sweepstakes Period”). Facebook, Inc.’s computer is the official time-keeping device for the Sweepstakes. Eligible Entrants can enter the Sweepstakes through the one (1) method of entry:

All entries must be received by 11:59:59 p.m. PDT on March 15, 2020 to be eligible for the drawing. Limit one (1) entry per person/email address for the entire Sweepstakes Period. Multiple entries from any person or email address will be void. Entries generated by script, macro or other automated means or by any means that subvert the entry process, as determined in the sole discretion of Sponsor, are void. All entries become of the property of Sponsor.

GENERAL CONDITIONS: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (i) infection by computer virus, bugs, (ii) tampering, unauthorized intervention, (iii) fraud, (iv) technical failures, or (v) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the Prizes using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Sponsor’s Website; or acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to the identity of a winner based on an e-mail address, the winning entry will be declared by the authorized account holder of the e-mail address submitted at time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. Released Parties are not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to Entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes or downloading any materials in this Sweepstakes. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

DRAWING AND NOTIFICATION: The potential Grand Prize Winner will be selected in a random drawing from among all eligible entries received by the Sponsor whose decisions are final and binding. The Grand Prize drawing will be conducted, by the Sponsor, on or about June 30, 2020. Odds of winning the Grand Prize will depend on the total number of eligible entries received throughout the Sweepstakes Period. The potential Grand Prize Winner will be contacted by the Sponsor via email, as further described below in "ADDITIONAL PRIZE CONSIDERATIONS."

GRAND PRIZE: There will be **one (1) Grand Prize** awarded following the conclusion of the Sweepstakes Period. The Grand Prize Winner ("Grand Prize Winner" or "Prize Winner" or "Winner"), upon the Sponsor's confirmation of eligibility, will receive a Grand Prize package that includes:

1) Public Lands Passes

- a. One (1) America The Beautiful annual National Parks and Federal Recreational Lands pass. Valid for Entrance or standard amenity fees at Federal Recreation sites for passholder and occupants of a single, private non-commercial vehicle or passholder and three persons (16 and older) where per person fees are charged. Not covered: camping, tours, special recreation permits, etc. May not cover: organized groups or concession operated facilities or activities. Not responsible for misplaced, lost, or stolen cards. - b. One (1) Oregon State Parks 12 month day use parking permit. Valid for 12 months from the month purchased, the parking permit is honored at all 25 Oregon State Parks that charge a parking fee. The permit is valid only in parks operated by Oregon State Parks (see [map of parks charging a day-use parking fee](#)), and cannot be used for camping or extra vehicle fees. \$(30)**

- 2) AIRFARE** - Two (2) roundtrip coach class airfare tickets, to be purchased by Sponsor in an amount not to exceed \$2,000, between a major commercial airport near the Winner's primary residence and the Location, as determined by Sponsor. Should the total cost of airfare for the Winner and travel guest exceed \$2,000, the Winner will be responsible for the addition travel costs exceeding the \$2,000 airfare limit.
